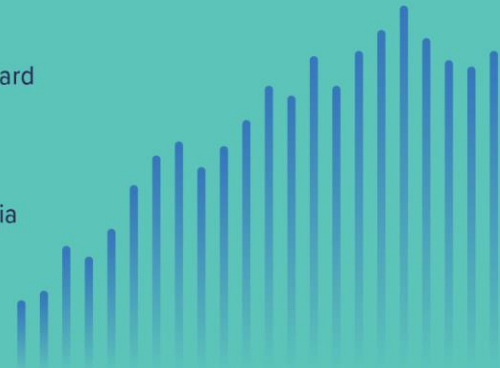
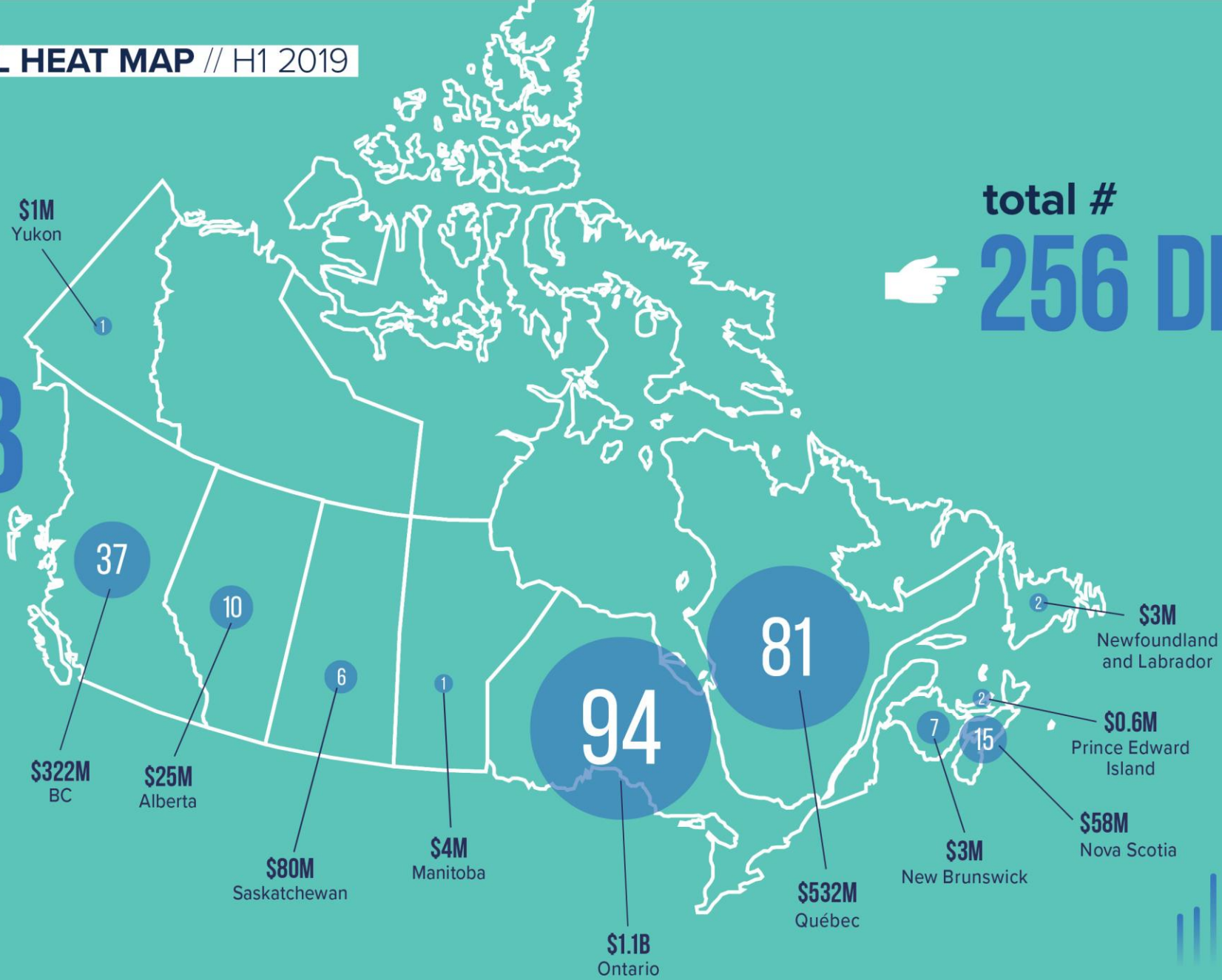

# VENTURE CAPITAL HEAT MAP // H1 2019

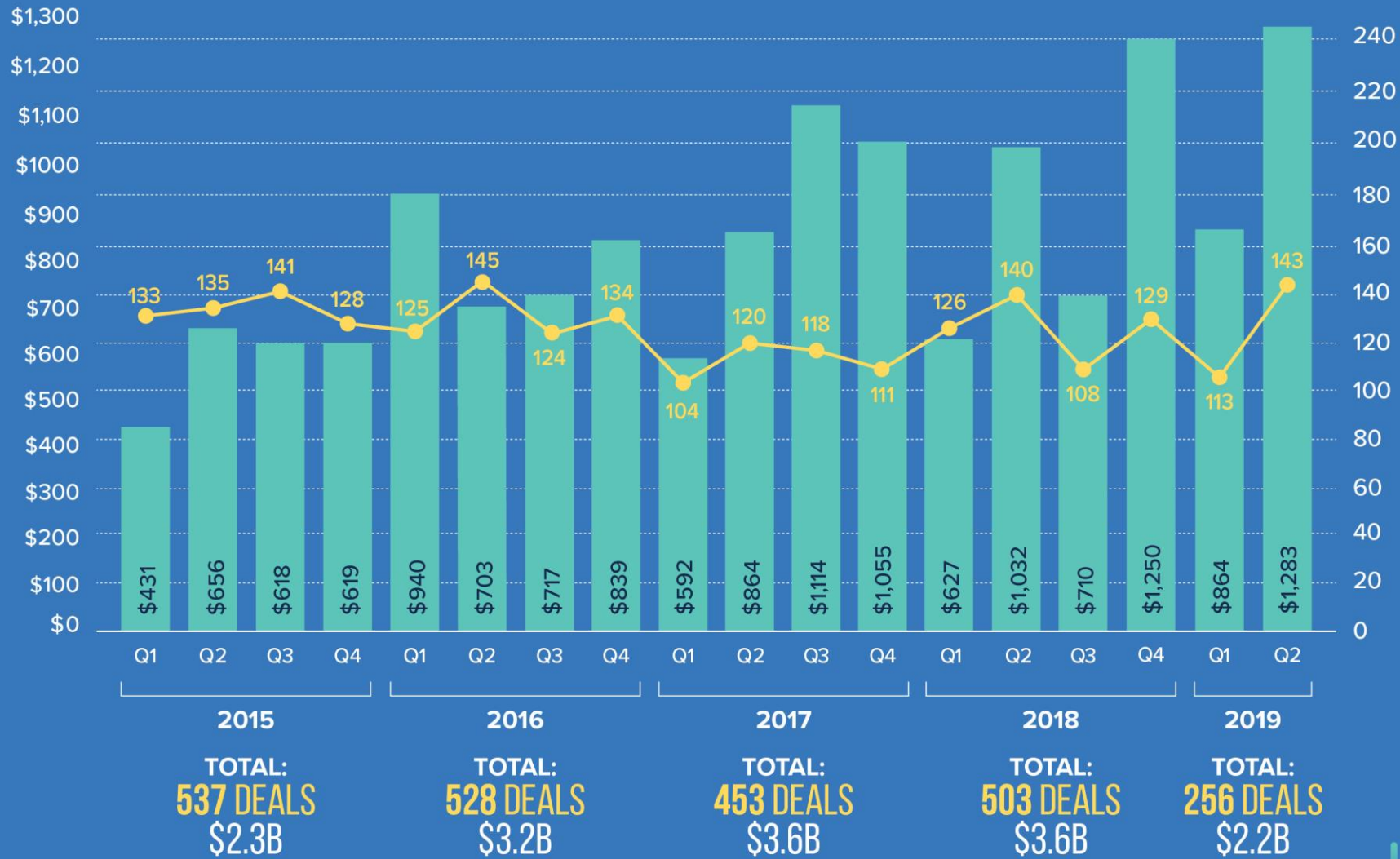

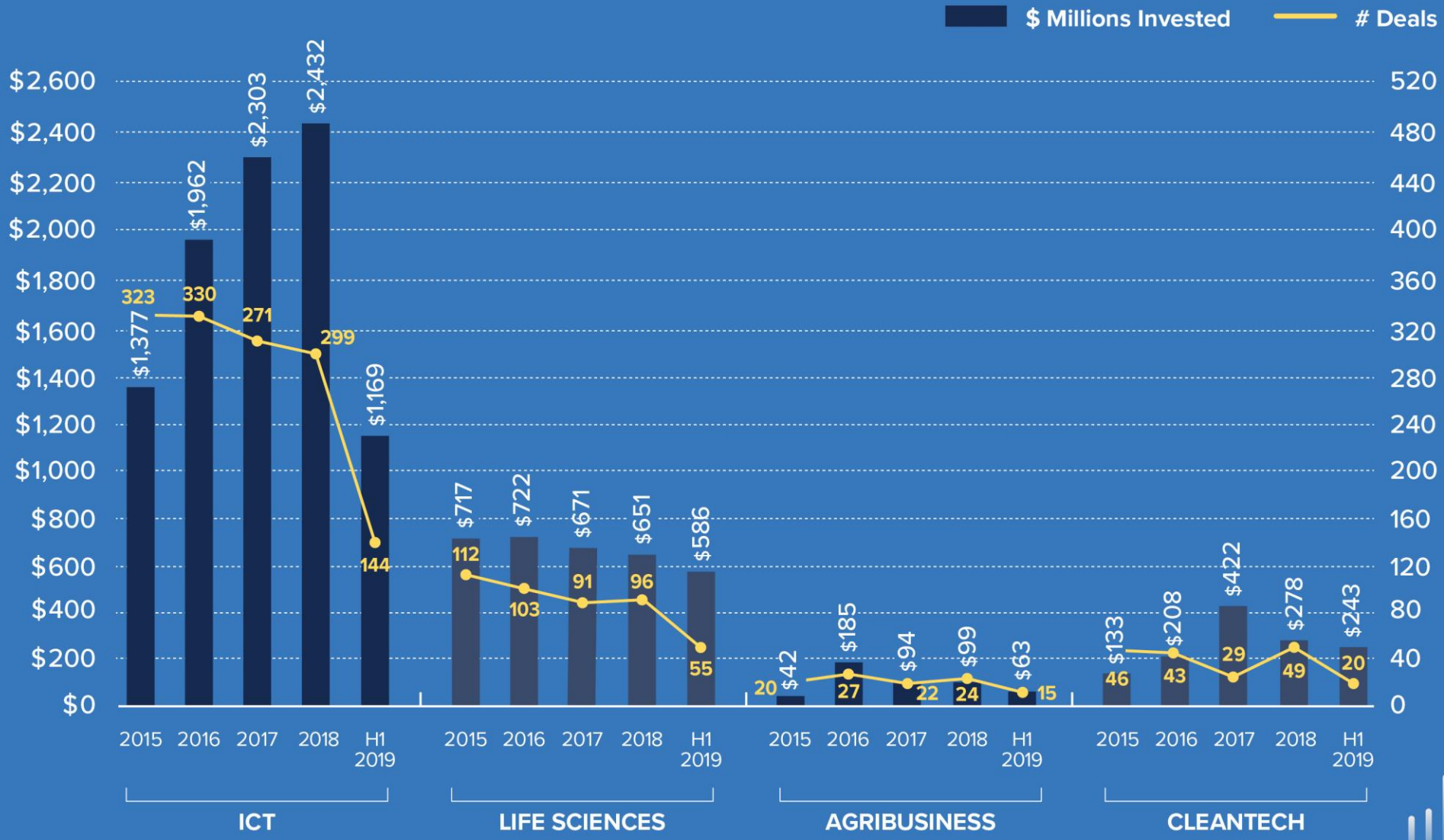


# QUARTER-OVER-QUARTER VC INVESTMENT ACTIVITY
